

# TOWN OF SEDGEWICK—THE SCOOP - August 2017

## August 24, 2017 Council Meeting Highlights

### AMSC Rebate Contest

Council approved utilization of a rebate of \$262 from AMSC for the purchase of a community BBQ to directly benefit the community. The Town will be entered into the AUMA Rebate Contest with the winners receiving a free AUMA convention registration worth \$700.

### Recreation Board Bylaw

Council gave first, second, and third reading for Bylaw 532/17, the Town of Sedgewick Recreation Board Bylaw. The Bylaw formally establishes membership, powers, duties and limitations of the Recreation Board.

### FRSWMA Membership Agreement

Council approved a membership agreement between the Town of Sedgewick and the Flagstaff Regional Solid Waste Management Association.

### Solid Waste Bylaw

Council gave first reading to Bylaw 533/17, the Solid Waste Bylaw. The Bylaw sets standards for the following:

Requirement of all solid waste to be placed in receptacles with properly fitted covers.

Proper placement of receptacles put out for collection.

Upkeep of receptacles.

Parameters of yard waste collection.

Enforcement of the Bylaw and associated penalties.

### Development Permit Application

Council cancelled Development Permit 2017-05 and approved Permit 2017-07 allowing for a variance on the height of a maintenance shop expansion and office building from 10.0 to 11.5 meters.

### SOLID WASTE BYLAW 533/17

Council approved First Reading to Solid Waste Management Bylaw 533/17 on August 24th. The Bylaw states: "Council of the Town of Sedgewick is committed to the responsible reduction and management of municipal solid waste."

The bylaw defines Residential waste, Recyclable materials, acceptable Yard Waste and waste 'receptacles.'

The bylaw defines receptacle: means an animal proof container constructed of non-corrosive durable metal, rubber or plastic, equipped with a water tight cover and at least one (1) handle to facilitate handling.

Further, the Bylaw states: All waste must be contained in receptacles as defined... All receptacles must be fitted with covers, which must remain closed. The covers must be suitable to prevent residential waste from spilling or blowing from the receptacles and to prevent water or animals from entering.

The bylaw addresses acceptable Yard Waste and collection thereof: Between the months of April and October, yard waste, except for leaves and grass clippings, will be picked up on a weekly basis on a day determined by the Chief Administrative Officer. Yard waste must be placed in a paper bag or be bundled and tied with twine. Bundles must be less than three (3) feet in length and weigh less than fifty (50) pounds and branches must be less than three (3) inches in diameter.

Additionally: No person shall place their receptacle out for pickup prior to 5:00 pm the evening before the collection day, and no later than 7:00 am the morning of, to ensure pickup.

Council will re-address this bylaw at the September 21st, 2017 Regular Council meeting.
