2. Cost analysis of repairs verses demolition;
3. A list of known deficiencies at NE8-44-12 W4M and any quotes that have been obtained for repairs;
4. Overview of rental rates;
5. Statistics on potential residents refusal over the past twelve (12) months;
6. Written confirmation whether the \$2.2 million dollars that was allotted for the ten-unit self-contained independent living facility could be transferred to refurbishing the Flagstaff Lodge;

And having established the importance of the request that answers be provided by October 15<sup>th</sup>, 2015.

And finally that this request be cc'd to Wes Taylor, MLA and all other necessary persons. CARRIED.


