December 20, 2018 Council Regular Meeting Highlights

Bylaw 550 - Cemetery Bylaw

Council approved Cemetery Bylaw 550 that combined the components of and, rescinded Cemetery Bylaw 519 and Cremation Bylaw 493. See the complete Bylaw on the Town's website: www.sedgewick.ca

Bylaw 551 - Hawkers & Peddlers Bylaw

Bylaw 548 - Boulevard Bylaw

Policy 18-10 Municipal Lot Purchase Policy

Council approved the Sedgewick-Killam Natural Gas System Board's 2019 Budget as presented with no significant changes to the budget relative to 2018.


2019 FFCS Budget

2019 BEO Contract

Council directed Administration to enter into a contract with NIC.212 Services Ltd. to provide bylaw enforcement services and authorized Mr. Daryl Reinke to enforce Town of Sedgewick municipal bylaws in 2019.

2019 Monthly Tax Payment Plan

Per Tax Payment Bylaw 541, taxpayers may enter into an agreement with the municipality to pay taxes on a monthly basis, from Jan.1 to Dec.31, rather than paying all taxes by July 31st annually.

2019 DOG LICENSES ARE DUE

Pursuant to Dog Control Bylaw 464, every owner of a dog over the age of three months, shall, before January 31st annually, license each dog and pay a fee as follows:

#Dogs Spayed/Neutered Unaltered
1—2 \$15.00 each \$30 each
3 (Grandfathered) \$22.50 each \$45 each
2 (Grandfathered) \$30 each \$60 each

After January 31st, ALL LICENSE FEES DOUBLE

Are there some building upgrades in your 2019 plans? Finish that basement? Build a new garage? Add on a master suite? Here's a list of the Municipal and Provincial processes and permit requirements:

- a. For new construction, any structural changes, move-in buildings or, for construction valued over \$5,000:
 - 1. Municipal Development Permit—apply at the Town office.

Then upon approval of Development Permit, if required, proceed to:

- 2. Provincial Building Permit—forms are available at Town Office or online at: superiorsafetycodes.com or call Superior Safety Codes Inc. at: 1-888-358-5085.
- **b.** For Plumbing, Electrical or Natural Gas improvements:
 - 1. Provincial Permit required, per specified discipline, from Superior Safety Codes Inc. (See contact info above.)
