# TOWN OF SEDGEWICK BYLAW NO. 585/22 TOWN OF SEDGEWICK AMENDMENT #1 TO THE TRAFFIC BYLAW

A BYLAW OF THE TOWN OF SEDGEWICK, IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF AMENDING BYLAW 564, THE TOWN OF SEDGEWICK TRAFFIC BYLAW.

**WHEREAS**, the *Traffic Safety Act* authorizes a municipality to regulate and control vehicle traffic as well as parking on streets and property within the municipality;

**AND WHEREAS**, the *Municipal Government Act* allows a municipality to pass Bylaws as well as designate authority with respect to streets under its direction, control, and management;

**AND WHEREAS,** the Council of the Town of Sedgewick in the Province of Alberta wishes to amend Bylaw 564/19, the Town of Sedgewick Traffic Bylaw to provide for the "Use of Flashing Green Lights".

**NOW THEREFORE** the Council of the Town of Sedgewick in the Province of Alberta, duly assembled, enacts as follows:

#### 1. Citation

1.1. This bylaw may be cited as "Amendment #1 to the Traffic Bylaw".

#### 2. Provisions

- 2.1. Section 11 is hereby amended by adding the following:
  - 11.5 Full-time or volunteer firefighters may carry, on or in a vehicle, other than an emergency vehicle, a lamp that produces intermittent flashes of green light and may operate the lamp if the vehicle is proceeding to a fire or other emergency.
  - 11.6 No person other than a full-time or volunteer firefighter shall operate a lamp that produces intermittent flashes of green light.
  - 11.7 Nothing in this section shall be construed as to permit a full-time or volunteer firefighter to operate a vehicle in contravention of the Traffic Safety Act, Provincial regulations, or this Bylaw.

## 3. Severability

3.1. If any term of this Bylaw is found to be invalid, illegal, or unenforceable by a court or tribunal having the jurisdiction to do so, that term is to be considered to have been severed from the rest of this bylaw, and the rest of the bylaw remains in force unaffected by that finding or by the severance of that term.

### 4. Enactment

4.1. This Bylaw shall take effect at the date of final passing thereof.
